INFORMATION/INSTRUCTIONS APPLICATION FOR LICENCE TO OCCUPY CROWN LAND

Please supply as much detail as possible with the application, as this may avoid unnecessary delays.

Under current Statute and Department for Environment and Heritage Policy, Native Title and Biodiversity are to be considered in relation to every application received. This process can take some time. For example, should Native Title notifications be required in relation to this application, there is a mandatory 8 week comment period to be allowed for before the application process can proceed. For this reason, it is advisable to submit your application as early as possible.

Please Note: No works on Crown land can proceed until the appropriate licence is issued.

Should the occupation be required for a purpose, which may require

1. works such as excavation or infill; or
2. infrastructure to be erected such as pumps, pipelines, pump sheds, river landings (jetties), boat ramps, residential development

A Development Application may be required. Please check with the local council for the area concerned.

Please supply a copy of the Development Application and all specifications with your application to this Department or alternatively, details of the council officer who has advised that Development approval is not required.

A map or plan showing where the structure will be situated in relation to the property it serves (the property you own) should be included with the application.

If the application is to licence an existing structure, a photograph of the structure provided with the application would be helpful.
