

SOUTH AUSTRALIAN HERITAGE ACT, 1978

Designation of State Heritage Area

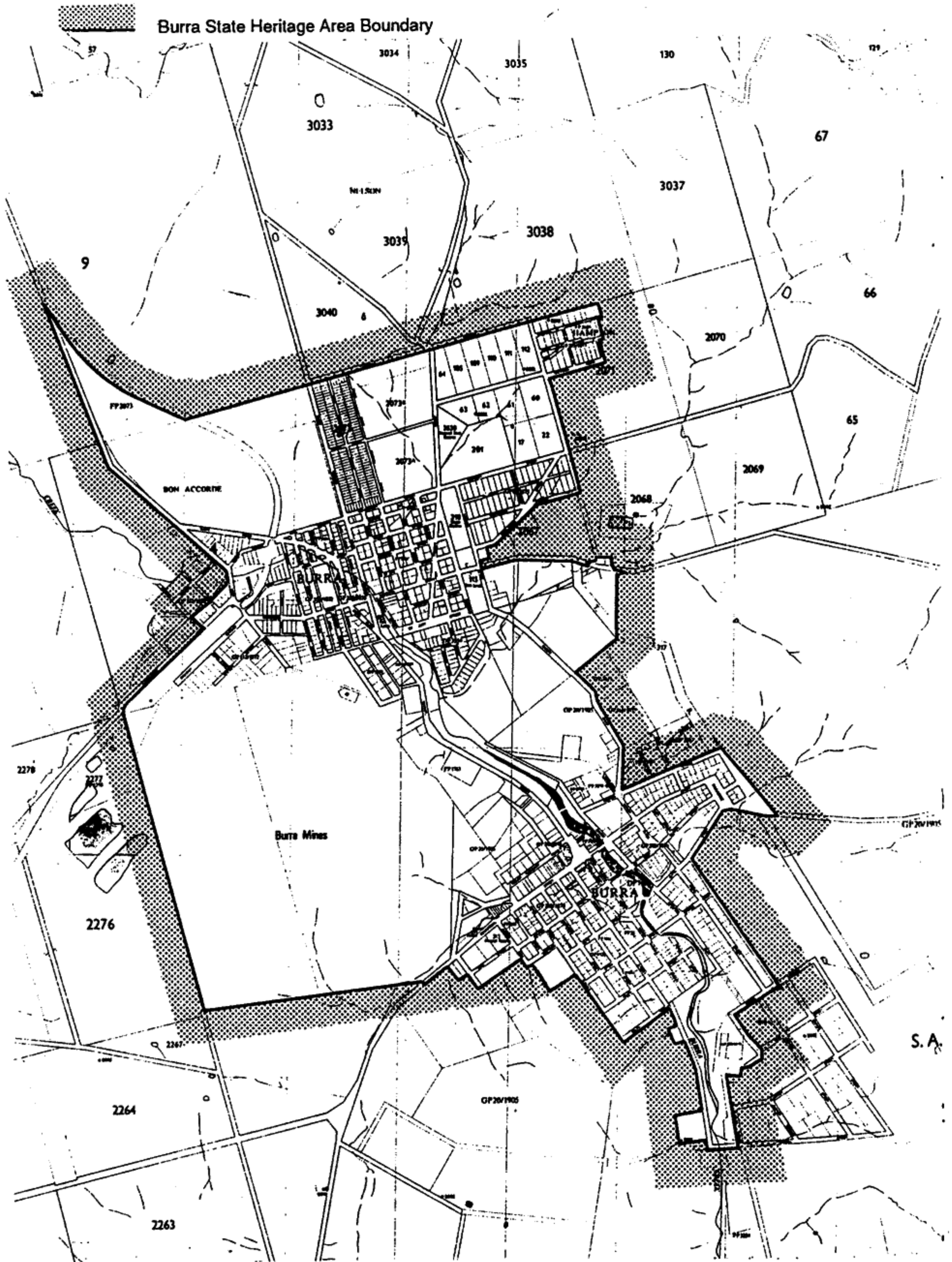
WHERE the Minister considers that an area of land is part of the physical, social or cultural heritage of the State and that it has significant aesthetic, historical or cultural interest, then the Minister may designate that area of land as a State Heritage area.

Pursuant to the provisions of section 13 of the South Australian Heritage Act, 1978-1980, I the Minister administering the South Australian Heritage Act, 1978, hereby designate the area defined and shown in The Schedule as a State Heritage area.

The Schedule

All that part of the area of the District Council of Burra Burra, bounded as follows:

Commencing at a point on the intersection of the eastern boundary of Barrier Highway and the western boundary of the railway line in part section 9, Hundred of Kooringa; thence proceeding south-easterly along the said railway line boundary to the common boundary of sections 4 and 9; thence north-easterly along the boundary of sections 4 and 9 to the intersection of the western boundary of West Terrace and the southern boundary of North Terrace; thence north-easterly along the southern boundary of North Terrace to the north-eastern corner of Lot 10 contained in F.P. 17437; thence south-easterly along the eastern boundary of Lot 10, with the production of the latter boundary, to the southern boundary of Wellington Road; thence south-westerly along the southern boundary of Wellington Road to the north-eastern corner of Lot 117 contained in F.P. 17437; thence south-westerly along the eastern boundary of Lot 117 to the southern boundary of Quarry Street; thence westerly along the southern boundary of Quarry Street to the eastern boundary of Thomas Street; thence south-easterly along the eastern boundary of Thomas Street to the southern boundary of Victoria Road; thence south-westerly along the southern boundary of Victoria Road to the western boundary of section 2071; thence south easterly along the western boundary of section 2071 and the western boundary of section 2068 to the production of Morrision Street; thence south-westerly along the southern boundary of Morrision Street to the southern boundary of Penglawdd Street; thence south-westerly along Penglawdd Street to the northern corner of the allotment contained in C.T. 4098/160; thence south-easterly along the eastern boundary of the allotment—C.T. 4098/160 to the south-eastern corner of the latter allotment; thence south-westerly along the southern boundary of the allotment—C.T. 4098/160 to the eastern boundary of Smelts Road; thence south-easterly along the southern boundary of Morgan Road—R.P. 2941 to the north-western boundary of the allotment—C.T. 4359/697; thence generally north-easterly, north-westerly, north-easterly, south-easterly and north-easterly along the northern boundary of the latter allotment to the north-western corner of the allotment—C.T. 203/54; thence south-easterly and southerly along the boundary of the allotment—C.T. 203/54, with the latter boundary extension to the northern boundary of the allotment—C.T. 1094/121; thence south-easterly to the eastern corner of the latter allotment; thence south-westerly to the northern corner of part Block 10 contained in G.R.O. 20/1905; thence south-westerly along the eastern boundary of part Block 10 to the northern corner of the allotment contained in C.T. 3505/20; thence south-westerly along the north-western boundary of the latter allotment and Lot 21 contained in D.P. 3813 to the eastern boundary of Smelts Road; thence south-easterly and south-westerly along the eastern boundary of Smelts Road to the northern boundary of Paxton Terrace; thence north-easterly along the northern boundary of Paxton Terrace to the south-western boundary of Block 9 contained in C.T. 1577/57; thence south-easterly along the south-western boundary of the said Block 9 to the northern boundary of the allotment contained in C.T. 2265/7; thence north-westerly along the northern boundary of the allotment—C.T. 2265/7 to the north-eastern corner of the allotment contained in C.T. 1163/121; thence north-westerly along the northern boundary of the allotments contained in C.T. 1163/121 and C.T. 3739/182 to the southern boundary of Blyth Street; thence south-westerly along the southern boundary of Blyth Street to the eastern boundary of George Street and the eastern boundary of Lots 333 to 343, 1 and 2 contained in F.P. 13820 and Lot 1001 contained in F.P. 25075 and extended to the southern boundary of Spring Street; thence south-westerly along the southern boundary of Spring Street to the western corner of Lot 221 contained in D.P. 1672; thence south-easterly along the western boundary of Lots 221, 220 and 219, crossing Beck Street to the north-western corner of Lot 218; thence southerly along the latter allotment boundary to the northern corner of Lot 214; thence south-westerly and north-westerly along the northern boundary of Lots 214 and 204 to the western corner of Lot 204; thence south-easterly along the western boundary of Lots 204, 203 and 202 and the western boundary of Peacock Street to the northern boundary of Rymill Street; thence south-westerly along the northern boundary of Rymill Street to the south-eastern corner of Lot 99 contained in D.P. 20147; thence north-westerly along the eastern boundary of Lot 99 to the south-eastern corner of Block 21 contained in G.R.O. 20/1905; thence south-westerly, north-westerly and north-easterly along the boundary of Block 21 to the eastern boundary of Lot 99; thence north-westerly along the eastern boundary of Lot 99 to the south-eastern corner of the allotment being part section 1 contained in Plan B-171; thence south-westerly, north-westerly and north-easterly along the boundary of part section 1 in Plan B-171 to the eastern boundary of Lot 99; thence north-westerly along the eastern boundary of Lot 99 to the southern boundary of South Terrace; thence south-westerly along the southern boundary of South Terrace to the extension of the western boundary of Lot 131; thence north-westerly along the western boundary of Lots 131 and 130 and the western boundary of Vineyard Terrace to the northern corner of allotment contained in C.T. 886/26; thence south-westerly along the northern boundary of the allotment—C.T. 886/26 to the south-western corner of Block 15A contained in G.R.O. 20/1905; thence north-westerly along the western boundary of Block 15A to the southern boundary of part Lot 63 contained in C.T. 1992/119; thence south-westerly, north-westerly and south-westerly along the eastern boundary of Lot 201 contained in D.P. 18212; thence north-westerly, south-westerly and north-westerly along the boundary of Lot 201 to the southern boundary of Barrier Highway; thence south-westerly along the southern boundary of Barrier Highway to a point directly opposite the south-eastern corner of the allotment contained in C.T. 3761/115 on the Barrier Highway boundary; thence north-westerly to the said corner; thence south-westerly along the southern boundary of part section 1—C.T. 3761/115 and Lot 2 contained in D.P. 18682 to the south-western corner of Lot 2; thence north-westerly along the western boundary of Lot 2 and traversing north-westerly along the section boundary of sections 1 and 2276 to the southern boundary of Copperhouse Street; thence north-easterly along the southern boundary of Copperhouse Street to a point on the said boundary directly opposite the extension of the western boundary of Lot 123; thence north-westerly along the western boundary of Lot 123 to the western corner of Lot 123; thence north-easterly along the northern boundary of Lots 123, 122, 121, 120, 119, 118, 117, 116 and 115 to the western boundary of West Street; thence north-westerly along the western boundary of West Street to a point on the said boundary directly opposite the commencement point; thence easterly to the point of commencement.
