## Application for a Permit to **HARVEST AND SELL OR USE PROTECTED ANIMALS – KANGAROO FIELD PROCESSOR PERMIT (CLASS 14)**

Issued pursuant to [Section 60J, National Parks and Wildlife Act, 1972](#)

A permit of this type allows the holder to shoot kangaroos on more than one property within the commercial harvest area of SA, and permits the sale of kangaroo carcasses to authorised Kangaroo Meat Processors.

### **PLEASE READ THE FOLLOWING CAREFULLY**

The applicant is required to understand and comply with the National Parks and Wildlife (Kangaroo Harvesting) Regulations 2018 and the National Parks and Wildlife (Wildlife) Regulations 2016 under the *National Parks and Wildlife Act 1972*, and the National Code of Practice for the Humane Shooting of Kangaroos and Wallabies for Commercial Purposes (Environment Australia, 1990, as amended).

Download a copy of the [National Parks and Wildlife Act 1972](#) and Regulations. Should this permit be approved, an information package including the National Code of Practice for the Humane Shooting of Kangaroos and Wallabies for Commercial Purposes (Environment Australia, 1990, as amended) will be provided to you during the application interview or provided with your permit.

Prior to a permit being issued, the applicant must provide a copy of their Certificate of Accreditation for the Field Harvesting of Kangaroos from the Food Safety Program of the Department for Primary Industries and Regions SA. Before being accredited, the applicant must have successfully completed the TAFE Certificates in Game Meat Field Processing Kangaroo (or equivalent) and Firearms Proficiency Course for Kangaroo Field Processors (or equivalent).

It is a requirement of South Australia Police (SAPOL) that all kangaroo field processors hold a current Class B7 Firearms Licence. They must also have their vehicle tray inspected to verify it meets the Australian Standard for Hygienic Production of Wild Game Meat for Human Consumption AS4464:2007. Copies of the course certificates, together with the FSP accreditation number, will need to be presented with this application.

The applicant is also required to attend an interview with staff of the Kangaroo Management Program at 9 Mackay Street, Port Augusta and present identification to verify their name and address (eg. driver's licence). Contact (08) 8648 5318 to arrange an interview.

### **It is an offence to make a misleading or false declaration on the application.**
