

APPLICATION FOR VENOMOUS SNAKE Specialist Keep and Sell Protected Animals (Class 3) South Australia 2018-19



A Specialist Keep and Sell Protected Animals Permit is a permit issued pursuant to section 58 of the *National Parks and Wildlife Act 1972* that entitles the holder (being a person who does not carry on the business of dealing in protected animals) to keep, sell or give specialist animals identified in the permit by reference to the species or other class to which they belong.

This application covers applicants wishing to apply for the keeping of venomous snakes.

Information supplied on this form will enable your application to be processed as prescribed by the *National Parks and Wildlife Act 1972*. Your application must be assessed and a permit granted before you can proceed with the proposed activity. Your application may take up to eight (8) weeks to process.

5 Keeping Venomous Snakes

- Applicants wishing to apply for the keeping of venomous snakes must meet all requirements outlined in the Department of Environment, Water and Natural Resources Keep Venomous Snake Policy and Procedure.
- Applicants must be over 18 years of age. Consideration will be given to applicants over 15 years of age where their legal guardian provides a letter supporting the application.
- Access to venomous snakes must be limited to persons authorised by the permit holder (e.g. an employee who has undertaken a recognised course in venomous snake handling) or to persons holding permits with the same endorsement.
- Anyone handling venomous snake must have undertaken a recognised course in venomous snake handling/interaction. An ongoing commitment to ongoing training is encouraged.
- Permit holders must ensure that they minimise the possibility of snakebite to themselves or any other person. Permit Holders must possess suitable first aid equipment for the treatment of snakebite on site where venomous snakes are being held.

6. Endorsement steps

- Endorsements of permits for venomous snakes will commence with the lowest category unless the applicant can provide evidence to support extensive knowledge and experience in the husbandry of a higher level species
- Endorsement to the next level is subject to further application after a minimum of 12 months experience in the husbandry and keeping of venomous snakes has been gained (at a lower level endorsement).

7- Supporting documents

1. Please supply two (2) written references from two people who can attest your ability, knowledge and experience in the handling of venomous snakes. These referees must hold, or have held, specialist permits authorising the keeping of venomous snakes and be experienced in the husbandry of these animals in South Australia or interstate.
2. Please provide a copy of a certificate or written competency statement to show training you have undertaken to gain experience in handling venomous snakes (e.g. Venomous Snake Handler's Certificate).
3. Please provide a copy of a current senior first aid certificate issued by an approved first aid training provider (e.g. St John or Red Cross). The course undertaken must include a component dealing with snakebite treatment and/or provide evidence of competency certified by a medical practitioner who specialises in this field.
4. Please provide a written emergency response plan which includes procedures for managing any incident involving snake bite (self or others) and snake escape.
5. It is a minimum requirement that all venomous snakes shall be kept in either lockable, escape proof containers or in containers within a lockable and sealed room which prevent unauthorised entry/and or tampering with cages and the escape of snakes. Please provide photos of your lockable, escape proof containers and/or lockable sealed room.
