Issued pursuant to [Section 58, National Parks and Wildlife Act, 1972](#)

A permit of this type is required of any person intending to tan and sell the skins of kangaroos.

Please read the following carefully.

The applicant must have comprehensive knowledge of the National Parks and Wildlife (Kangaroo Harvesting) Regulations 2018 and the National Parks and Wildlife (Wildlife) Regulations 2016 under the *National Parks and Wildlife Act 1972* as amended.

The applicant is also required to attend an interview and present identification to verify their name and address (eg. driver's licence). Contact (08) 8648 5318 to arrange an interview.

Intended processing facilities will need to be inspected by staff from the Department for Environment and Water Kangaroo Management Program.

It is an offence to make a misleading or false declaration on the application.
