

BASIC HUNTING PERMIT (Class 1, 3, 5, 7) SOUTH AUSTRALIA 2016-17



A Basic Hunting Permit is a permit issued pursuant to section 68A of the *National Parks and Wildlife Act 1972* (the Act) that entitles the holder to hunt or have possession of any firearm* or device for the purpose of hunting.

Information supplied on this form will enable your application to be processed as prescribed by the Act. Your application must be assessed and a permit granted before you can proceed with the proposed activity. Your application may take up to ten (10) business days to process.

*All holders of an SA Hunting permit must have the appropriate Firearms Licence when using a firearm and obey all relevant legislation regarding firearms. Check with your nearest police station or the SA Firearms branch.
