

IMPORT PROTECTED ANIMALS PERMIT APPLICATION SOUTH AUSTRALIA 2018-19

An Import Permit is required to transport any protected animals (including exempt protected animals and the carcass or the eggs of a protected animal) to a place inside South Australia from a place outside of South Australia. Regulating the movement of protected animals allows the Department to conduct the necessary checks to ensure that protected animals have been legally acquired and also assists with safeguarding against biosecurity risks (e.g. disease prevention).

An Import Permit is issued pursuant to Section 59 of the South Australian *National Parks and Wildlife Act 1972* and is subject to the provisions of the Act, Regulations and Proclamations thereunder.

Where the application applies to -

1. the movement of live protected animals, or the eggs or carcass of a protected animal, the permit is valid for one consignment only. The permit expires one month from the date of issue or immediately after the consignment has taken place;
2. the import of kangaroo carcasses or skins legally acquired from an approved interstate Kangaroo Management Program, the applicant must be the holder of a Class 7 Permit to Sell Protected Animals (Kangaroo Meat Processor) or a Class 8 Permit to Sell Protected Animals (Tannery and Skins). The permit holder is permitted to receive multiple consignments and the sum total of all consignments received must not exceed the quantity per species that is specified in the permit.

Information supplied on this form will assist the Department with processing your application. Your application must be assessed and a permit granted before you can proceed with the proposed activity. Please allow two (2) business days.

Note: Where the proposed activity involves the movement of protected animals or samples taken pursuant to a scientific research permit please contact DEW research permits at DEWresearchpermits@sa.gov.au to obtain the necessary approvals.
