



## Water Compliance Reporting

The Department for Environment and Water (DEW) is responsible for managing South Australia's water resources for the future. This includes monitoring water users who take and use water from prescribed water sources such as a dam, bore, stream, river or creek to ensure they are meeting their legal obligations.

DEW is required to report on any water use compliance breaches as part of the [National framework for compliance and enforcement systems for water resource management](#).

### Water Compliance Activities Conducted in 2017-18<sup>1</sup>

Tables 1 below summarises the types of compliance actions undertaken in for each prescribed water resource in South Australia in 2017-18. These actions relate to offences which occurred in the 2017-18 water use year.

Table 2 details the compliance actions undertaken pertaining to wells and well drillers licences for the 2017-18 water use year.

Table 3 details specific, targeted water compliance operations that occurred in 2017-18 and where data was available, the number of compliant and non-compliant sites.

Table 4 details the number of site visits carried out as part of business as usual compliance follow up in each prescribed water resource area in South Australia.

Table 5 details the number of site visits undertaken for targeted compliance programs for the 2017-18 water use year.

## STATEWIDE PROPOSED TARGETED WATER COMPLIANCE MONITORING OPERATIONAL PLAN FOR 2018-2019

Proposed targeted water compliance operations for the 2018-19 water use year (not part of the annual meter reading program) include the following:

Within the South Australian Murray-Darling Basin Natural Resources Management Region:

- Site inspections of unmetered water instruments in the River Murray Prescribed Watercourse (PWC)
- Audit of unmetered water instruments in the Marne Saunders Prescribed Wells Area (PWA)
- Audit of unmetered water instruments in the Eastern Mount Lofty Ranges Prescribed Water Resources Area (PWRA)
- Analysis of meter self-reads in the River Murray PWC
- Education activity to increase awareness of licensing options for on farm irrigation activities in the Mallee PWA

Outside of the South Australian Murray-Darling Basin Natural Resources Management Region:

- Inspection of the integrity of existing installed meters in the Lower Limestone Coast PWA
- Inspection of the integrity of existing installed meters in the Northern Adelaide Plains PWA
- Audit of unmetered water instruments in the Northern Adelaide Plains PWA
- Inspection of deferred meters within the Western Mount Lofty Ranges PWRA
- Audit of spring fed dams within the Western Mount Lofty Ranges PWRA
